<p align="center">General terms and conditions in 2024 for a covering of ROCK'N ROLL SEMILLY per mare €1700 euros which includes 3 doses (1 dose = 1 straw to use in deep Artificial Insemination on ovulation)</p> <p>ICSI and frozen embryos are strictly forbidden under the terms of this contract, but can be available under a different contract. Then, if you expect to use those straws in a different way than deep AI or fresh / chilled embryo transfer, please contact the seller.</p>		
The seller confirms that:		
<p align="center">He sells not less than 3 doses of ROCK'N ROLL SEMILLY for €1700 euros <u>live foal guarantee, taxes, shipment and cost for the health certificate excluded</u></p> <p>He provides for 1 Breeder's Certificate per dose sold. If multiple embryos are retrieved from one breeding with 1 dose, it will be the responsibility of the purchaser to notify the seller each foal born. In this case, there will be additional costs of €1700 euros plus taxes per each additional live foal derived from the use of a dose, immaterial of when, for whom and where it is achieved.</p> <p>He will release the semen when this contract will be signed, and the invoice paid.</p>		
The purchaser confirms that:		
<p>He buys: (number of doses) / identification n°</p> <p>He has understood the terms of this agreement and accepts them entirely. He becomes responsible for those straws bought and commits to use them in deep AI only, not to freeze any embryo nor make any ICSI. He commits to inform the seller of the birth of each foal produced by those straws within 48h after his birth and use the birth certificate which will then be given by the seller to declare the birth of his foal to any studbook. If more than 1 foal born derived from the use of 1 straw, he commits to pay to the seller the additional costs of €1700 euros plus taxes per each additional foal born.</p> <p>Any semen, purchased under this contract, will always remain under the terms of this contract for its lifespan. The purchaser is fully liable, including in the case of resale. In this case, the new buyer must be advised of this contract, agree with it and sign it. A copy of this new contract must be sent by the purchaser to the seller with return receipt.</p>		
The seller and the purchaser confirm that:		
<p>This agreement shall be governed by the laws of France with meaningful penalties in case of contract defaults. Attempted fraud committed by the purchaser is punishable by an unconditional fine per non declared additional foal of €9900 + VAT in addition to a penalty payment of 10% per year delay since the foal was born until the year the fraud is discovered.</p>
