<p>The Purchaser agrees to pay <b>€1950 Euros</b> (5,5% taxes excluded) for booking <b>one ICSI session with DIAMANT DE SEMILLY which will be done the .... / .... / .....</b> at AVANTEA for the Mare: ..... The Purchaser agrees to breed <u>this Mare specified and only this one.</u></p> <p>This amount is payable prior to the ICSI session and non-refundable, no matter how many oocytes are collected or embryos are conceived.</p> <p>The semen provided through this contract can be used only for making <b>one ICSI session with the oocytes of the specified Mare collected from one Ovum Pick Up.</b> This OPU is done the .... / .... / ..... at :  Name of the OPU center: ..... Email: .....</p> <p>Through this contract, the Purchaser allows the OPU center to give the result of the number of oocytes collected to the Seller. <u>This result must be sent to the Seller before the ICSI session.</u></p> <p>The Seller will release at AVANTEA a piece of straw needed for making one ICSI session when <u>this contract will be signed, the number of oocytes collected given and the invoice paid.</u></p> <p><b>The purchaser is not allowed to share this ICSI session without the prior consent of the Seller.</b> Any other use of sperm coming from this piece of straw thawed for this ICSI session will be subject to another contract. According to the number of mares sharing one single ICSI session, the Seller practices tapering charges.</p> <p>It will solely be the responsibility of the Purchaser to pay all the other nomination fees for OPU, ICSI, vitrification of the embryos, storage and so on...</p> <p>Through this contract, the Purchaser agrees to give the result of the number of embryos conceived to the Seller within 15 days after the ICSI session, and the information regarding the pregnancy rates and foals born the years after.</p> <p>All frozen embryos are property of the Seller until the invoice of <b>€1950 Euros</b> (5,5% taxes excluded) is not fully paid by the Purchaser to the Seller. In case of payment problem, if this amount is not fully paid to the Seller within 1 month after the date of the signature of this contract, the Purchaser recognizes that he is not able to pay for it and the Seller becomes their definitive owner. Then the Seller is allowed to get those embryos out of AVANTEA and the Purchaser waives all recourse.</p> <p>The Purchaser and the Seller confirm that they have understood the terms of this agreement and accept them entirely.</p>
