The seller confirms that:		
<p style="text-align: center;">He sells 1 frozen straw from DIAMANT DE SEMILLY for €1350 Euros <u>The live foal guarantee, taxes, shipment and the costs of the health certificate are excluded</u></p> <p>He uses 1 straw (0,5ml) for deep horn Artificial Insemination on ovulation with on average an exceptional fertility rate. Diamant's semen was frozen when he was younger, with only the good batches being kept (motility rate guaranteed by Eurogen).</p> <p>ICSI and frozen embryos are strictly forbidden under the terms of this contract. However, can be an option under a different contract. Then, if you would like to use the straws in a different way to deep AI or fresh / chilled embryo transfer, please contact the seller.</p> <p style="text-align: center;"><u>1 straw is sold with 1 Breeder's Certificate and 1 born foal being a maximum</u></p> <p>If multiple embryos are retrieved from one breeding with 1 straw, it will be the responsibility of the purchaser to notify the seller the birth of each foal. In this case, there will be additional costs of €1350 plus taxes per each additional living foal derived from the use of this straw. This would be immaterial of when, for whom and where it is achieved.</p> <p>He will release the semen when this contract has been signed and the invoice paid.</p>		
The purchaser confirms that:		
He buys: (number of straws) / identification n°		
He has understood the terms of this agreement and accepts them entirely. He becomes responsible for those straws bought and commits to use them in deep AI only. No freezing of any embryos or the making of any ICSI is permitted. He commits to inform the Seller of the birth of each foal produced by these straws within 48h after their birth. The birth certificate will then be provided by the Seller to declare the birth of his foal to any studbook. If more than 1 foal born is derived from the use of 1 straw, he commits to pay to the seller the additional costs of €1350 plus taxes per each additional foal born.		
Any semen purchased under this contract will always remain under the terms of this contract for its lifespan. The purchaser is fully liable, including in the case of resale. In this case, the new buyer must be advised of this contract, agree with it and sign it. A copy of this new contract must be sent by the purchaser to the seller with a return receipt.		
The seller and the purchaser confirm that:		
This agreement shall be governed by the French law, with meaningful penalties in case of contract defaults. Attempted fraud committed by the Purchaser is punishable by an unconditional fine per non declared additional foal of €9900 + VAT in addition to a penalty payment of 10% interest per year since the foal was born, until the year the fraud is confirmed.
