<b>The Seller confirms that:</b>		
<b>ANDIAMO SEMILLY Stud Fee = €1500 Euros (taxes, shipment and TRACES costs excluded)</b>		
When this contract is signed and the invoices paid, the Seller can provide: <input type="checkbox"/> <b>chilled semen</b> (orders have to be done before 9h30 on Monday, Wednesday or Friday by email at contact@semilly.com) <input type="checkbox"/> <b>3 doses of 1 straw per dose</b> (so 3 straws identification n° .....). 1 dose has to be used in deep horn insemination on ovulation per season. This insemination has to be completed no more than 24h before ovulation and no more than 6 hours after ovulation. In any case, the doses (chilled or frozen) are unable to be split. The semen shall only be used on the mare detailed in this contract. <b>The semen is not permitted to be used for ICSI, frozen embryos or other advanced reproduction techniques.</b> <b>Eventual remaining semen remains the property of the Seller.</b> The Seller provides <b>1 birth declaration per covering fee paid</b> . It will be sent to the Purchaser when the foal is born.		
<b>The Purchaser confirms that:</b>		
He has understood the terms of this agreement. He is responsible for the covering bought under this contract and the use of the semen received. He declares to use it for the following <b>Mare</b> : Name ..... UELN ..... / Breed: ..... / Color: ..... / Sire: ..... He would like the seller to deliver the semen to (name + full address + phone number) ..... (specify the address required for TRACES documents if different ..... ) Transportation costs are to be paid by the purchaser up front. The purchaser is aware of shipping conditions.		
<b>The Purchaser certifies that the doses sent by the Seller won't be divided, nor resold, nor used for another mare other than the one detailed without the prior agreement with the Seller. He also attests that his veterinarian is aware of these conditions.</b> The Purchaser declares that he will make an <u>Embryo Transfer</u> after insemination <input type="checkbox"/> <b>NO</b> (if the Purchaser decides to change his mind, he will have to declare it to the Seller before doing any ET) <input type="checkbox"/> <b>YES</b> (the Purchaser commits to notify the Seller when multiple pregnancies are achieved. The embryos collected are not allowed to be vitrified (frozen). They must be directly transferred or chilled and transferred at least the day after) The Purchaser attests that the Mare and in the case of embryo transfer, the recipient mares, are <b>well vaccinated against Flu, Tetanus and EHV</b> (in order to prevent as much as possible EHV abortion). The Purchaser is responsible for notifying the Seller of any pregnancies by the 1st December. In the event of the mare or surrogate mares not scanning in foal, a 'not in foal certificate for the mare and its surrogate mares' from a certified veterinarian must be provided by a registered post, with the all the used empty straws by the 1st December. In this scenario and if semen is still available, the Seller will provide for the year after, which would be in the form of chilled semen or 3 doses of frozen semen in the same condition as the previous attempt. The mare can also be inseminated without an AI restriction at Haras de Semilly. The Purchaser commits to <b>notify the Seller of the birth of each foal</b> produced within 48h after birth. The birth certificate will then be provided by the seller to declare the birth of the purchaser's foal to any studbook. <b>If more than 1 foal born derived from the use of the semen provided, the Purchaser commits to pay the Seller the additional stud fee for each additional foal born, before declaring of the birth of these additional foals to any studbook.</b> Any semen purchased under this contract will always remain under the terms of this contract for its lifespan, where it is unable to be used or resold to anybody else without the agreement of the Seller.		
<b>The seller and the purchaser confirm that:</b>		
This agreement shall be governed by the French law, with meaningful penalties in the case of contract defaults. Attempted fraud committed by the purchaser is punishable by an unconditional fine per non declared additional foal of €9900 + vat, in addition to a penalty payment of 10% interest per year, since the foal was born until the year the fraud is confirmed.
