The Seller confirms that:			
KARAGANDA SEMILLY Stud Fee = €900 (taxes, shipment and TRACES costs excluded)			
<u>Provision of Semen and Birth Certificate:</u> Upon execution of this contract and payment of the invoices, the Seller shall provide chilled semen . Following the birth of the foal, the Seller shall provide the Purchaser with 1 birth certificate per covering fee paid .			
<u>Restrictions on Use:</u> The semen shall not be used for ICSI, frozen embryos, or any other advanced reproductive techniques.			
The Purchaser confirms that:			
He has understood the terms of this agreement. He is responsible for the covering purchased under this contract and for the use of the semen received. He declares to use it for the following Mare: Name UELN / Breed: / Color: / Sire:			
He requests that the Seller deliver the semen to (name + full address + phone number) If a different address is required for TRACES documents :			
Transportation costs shall be paid upfront by the Purchaser . The Purchaser acknowledges and accepts the shipping conditions.			
<u>Collection and Insemination Schedule:</u> The Purchaser understands that KARAGANDA will be competing this season in the 6 YO classes and then will not be collected every two days . The Purchaser shall instruct the veterinarian monitoring the mare to contact the Seller at the start of the mare's heat via WhatsApp at +33(0)672887151 , so that the Seller can coordinate shipment at the optimal time, taking into account the mare's cycle, the stallion's collection schedule according to his competition program, and transport constraints. Upon receipt, semen prepared in long-term extender must be stored at +5 °C , gently agitated before use to resuspend the spermatozoa, and insemination must be performed as close as possible to ovulation to maximize conception chances.			
The Purchaser certifies that the doses provided by the Seller shall not be divided, resold, or used for any mare other than the one specified above without the Seller's prior written consent. The Purchaser also confirms that the attending veterinarian is aware of these conditions.			
The Purchaser declares whether an embryo transfer will be performed: <input type="checkbox"/> NO (if the Purchaser changes his mind, he must notify the Seller prior to performing any ET) <input type="checkbox"/> YES (the Purchaser commits to notify the Seller when multiple pregnancies are achieved. Collected embryos shall not be vitrified (frozen) and must be either transferred directly or chilled and transferred no later than the following day .			
The Purchaser confirms that the Mare, and in the case of embryo transfer, any recipient mares, are fully vaccinated against Equine Influenza, Tetanus, and EHV , to minimize the risk of EHV-related abortion.			
The Seller and the Purchaser confirm that:			
<u>Not in Foal Certificate / Rebreeding:</u> In the event that the mare, or in the case of embryo transfer any recipient mares, does not scan in foal, the Purchaser shall notify the Seller and provide a "Not in Foal" certificate issued by a licensed veterinarian no later than 1 December of the breeding year. In such case, and provided that semen remains available for the following breeding season, the Purchaser shall pay the Seller €300 for a rebreeding contract, after which the Seller shall provide chilled semen under the same conditions as the previous attempt.			
<u>Foal Notification:</u> The Purchaser shall notify the Seller of the birth of each foal within 48 hours of birth . The Seller shall then provide the birth declaration required to register the foal with the relevant studbook. If more than one foal results from the use of the semen supplied under this contract, the Purchaser agrees to pay the Seller the additional stud fee for each additional foal born prior to the declaration or registration of such foal(s) with any studbook.			
<u>Ownership and Use of Semen:</u> Any semen purchased under this contract shall remain subject to the terms of this agreement for its entire lifespan and may not be used for any other purpose, transferred, or resold to any third party without the prior written consent of the Seller.			
<u>Governing Law and Penalties:</u> This agreement shall be governed by and construed in accordance with the laws of France. Any attempted fraud by the Purchaser, including the failure to declare additional foals resulting from the use of the semen supplied under this contract, shall result in an automatic penalty of €9,900 + VAT per undeclared foal, in addition to interest at a rate of 10% per year, calculated from the date of the foal's birth until the year in which the fraud is confirmed.
