<p><b>General terms and conditions in 2026 for a covering by KILIMANDJARO SEMILLY. Per mare, the price is €750 euros which includes 3 doses (1 dose = 2 straws to use in deep Artificial Insemination on ovulation)</b></p> <p><b>ICSI and frozen embryos are strictly forbidden under the terms of this contract.</b></p> <p>Then, if you would like to use these straws in a different way other than deep AI or fresh / chilled embryo transfer, please contact the seller.</p>		
<b>The seller confirms that:</b>		
<p><b>He sells not less than 3 doses of KILIMANDJARO SEMILLY for €750 euros</b>  <u>The live foal guarantee, taxes, shipment and cost for the health certificate are excluded</u></p> <p>He provides for <b>1 Breeder's Certificate per dose sold</b>. If multiple embryos are retrieved from one breeding with 1 dose, it will be the responsibility of the purchaser to notify the seller the birth of each foal. In this case, there will be additional costs of <b>€750 plus taxes per each additional live foal derived from the use of one dose. This would be</b> immaterial of when, for whom and where it is achieved.</p> <p>He will release the semen, when this contract has been signed and the invoice paid.</p>		
<b>The purchaser confirms that:</b>		
<p>He buys: (number of doses) <span style="background-color: yellow;">.....</span> / identification n° .....</p> <p>He has understood the terms of this agreement and accepts them entirely. He becomes responsible for the straws bought and commits to use them in deep AI only, with no option to freeze any embryo nor make any ICSI. <b>He commits to inform the seller of the birth of each foal produced by these straws within 48h after their birth. The birth certificate will be provided by the seller to declare the birth of his foal to any studbook. If more than 1 foal born is derived from the use of 2 straws, he commits to pay to the seller the additional costs of €750 plus taxes per each additional foal born.</b></p> <p>Any semen purchased under this contract will always remain under the terms of this contract for its lifespan. The purchaser is fully liable, including in the case of resale. In this case, the new buyer must be advised of this contract, agree with it and sign it. A copy of this new contract must be sent by the purchaser to the seller with a return receipt.</p>		
<b>The seller and the purchaser confirm that:</b>		
<p>This agreement shall be governed by the French law, with meaningful penalties in case of contract defaults. Attempted fraud committed by the purchaser is punishable by an unconditional fine per non declared additional foal of €9900 + vat, in addition to a penalty payment of 10% interest per year since the foal was born, until the year the fraud is confirmed.</p>
